Operational Greenhouse Gas Report

Summary

This report covers the emissions from anthropogenic sources of greenhouse gases (GHG), included within Gatehouse Bank's organisational boundary and meeting the requirements set out in ISO 14064-3: Specification with guidance for the validation and verification of greenhouse gas assertions.

- Organisational boundary: All operations (United Kingdom, three offices)
- Control approach: Operational Control
- Reporting period: 01/01/2019 – 31/12/2019
- GHG sources included:
 - o Scope 1: Natural Gas, Fuels, Refrigerants
 - o Scope 2: Purchased Electricity
 - o Scope 3: Business travel, waste

Our organisational carbon footprint has been verified by the Carbon Trust to standard ISO 14064-3: Specification with guidance for the validation and verification of greenhouse gas assertions.

Footprint analysis

The largest part of Gatehouse Bank's 2019 GHG footprint results from Scope 3 emissions, which constitute 60% of the total footprint. Within this category, the main contributor, making up 82% of the Scope 3 footprint, is air travel.

Scope 2 emissions amounted to 40% of the footprint. Scope 1 emissions amounted to 0% of the footprint.

The table below shows the breakdown of total footprint by scope and source. The largest contributor is air travel (48.94%), followed by purchased electricity (39.93%).

Gatehouse Bank's operational carbon footprint expressed as a ratio to number of staff is **1.26 tCO₂e per person** (163.79 tCO₂e/129 staff)
